

A Note from the Chair...

Our 2021 faculty recognition dinner was a landmark event. Not only were we able to step over the physical barrier between friends and colleagues that has sprung up in response to the pandemic and meet new associates, but we were reminded of the breadth and depth of accomplishments of our faculty during this difficult year. We also had the opportunity to recognize the many contributions to departmental initiatives of the Patrick Lee Foundation. The Foundation, which is devoted to finding creative ways of improving care of people with severe and chronic psychiatric illnesses, provided the funding that expanded continuum of care projects like the MAP clinic and the APIC program, underwrites a scholarship for medical students entering psychiatry who are committed to settling in Western New York, and underwrites our psychology internship. It is difficult to imagine a more productive and creative relationship than the one between the Department of Psychiatry and the Patrick Lee Foundation.

As stressful as the past year has been, it has given us the opportunity to learn how well we will meet our professional and personal responsibilities when we feel threatened. Given the nature of some acute illnesses, especially in the current climate in which criminals who will be released from custody immediately are brought to the hospital instead, an element of personal risk has always been a factor in psychiatry; but the continually blaring message of danger we are now exposed to as citizens has added a new dimension of fearfulness to entering the emergency department, the hospital, or any patient care area. As is often said, personal courage does not involve ignoring fear in such situations, but doing one's best despite fear. As clinicians, it is incumbent on us to transmit to our patients, all of whom are frightened of something, how to tell the difference between caution and paranoia and maximize their inner resources to do the best they can with the challenges they face. To the extent we can do so ourselves, we will be more effective healers for our patients and role models for our students. It is clear however, that we cannot succeed in isolation from each other. No one is- or should be- that independent.

As we continue to implement creative innovations that fill gaps in systems we cannot control, we should be encouraged by the realization that we can control our own behavior, and our ability to think clearly, when confronted by systemic exigencies, no matter how daunting. As we continue to look to each other, and to our outstanding collaborators in the community for encouragement and support, we can remain confident in our ability to surmount whatever trials continue to present themselves.

Patient Determination is Essential to Billing Cessation Codes

Question: The doctor saw a patient who complained about his tobacco use, but expressed no interest in quitting- at least not in the documentation in the medical record. Can it be inferred—from the fact the patient brought up the subject—that he was asking for cessation help and bill 99406 (Smoking and tobacco use cessation counseling visit; intermediate, greater than 3 minutes and up to 10 minutes) or 99407(...; greater than 10 minutes)?

Answer: No. You cannot bill 99406 or 99407 according to Current Procedural Terminology (CPT)®

In order to bill cessation codes, the items you must document—including the "assessed willingness to attempt to quit" - are:

- ♦ The patient's actual tobacco use.
- ♦ That you advised the patient to quit and the impact of smoking.
- ♦ That you assessed the patient's willingness to attempt to quit.
- ♦ That you provided methods and skills to stop tobacco use.
- ♦ Medication management of smoking cessation drugs.
- ♦ All resources that you provided.
- Setting an anticipated quit date.
- ♦ That follow-up was arranged.
- ♦ The amount of time you spent counseling the patient.



The documentation in the medical record must support the billing of the cessation code. If it does not, you do not have a separately identifiable service. A sentence in the medical record stating that the doctor spent 10 minutes counseling the patient does not meet the standard for the medical necessity that is needed to bill the cessation code(s).

If the patient's primary and the specialist are both providing cessation service, once the four-a-year visit total is met, claims will be denied.

Note: These codes cannot be used for vaping cessation counseling because vaping devices do not involve tobacco use. If your patient expresses interest in quitting vaping, bill codes 99401-99404 –unspecified preventive counseling codes.
